We do this by supporting our members to achieve wage growth and better conditions in the form of enterprise agreements, assist with workplace disputes and disciplinary actions and, importantly, actively lobby governments and business to consider the needs of our members and working people in general. ### RESIGNATION OF MEMBERSHIP

**Your Union membership is NOT automatically cancelled if you do not pay your dues.** Your account will continue to accumulate until we receive a resignation notice from you. Resignations cannot be accepted over the phone and must be made in writing and addressed to the State Secretary either via email to [info@etuwa.com.au](mailto:info@etuwa.com.au) or post to our Head Office, PO Box 356, BASSENDEAN WA 6934. If applicable, an account for outstanding fees will be forwarded and that must be settled before a clearance will be issued. You may receive a call from your Organiser to discuss your departure.

### UNEMPLOYMENT

**If you become unemployed please let us know.**

You are not required to pay Union fees while you are out of the workforce. Instead, we ask you to complete the a Credit Form to account for your periods of unemployment and apply them against your member account. Members who are unemployed and not paying Union fees are still entitled to Union benefits, provided your membership was paid up to the time of your unemployment and not in arrears. Please contact the office to get a credit form and to get up-to-date sector info on who's hiring.

### INDUSTRIAL REPRESENTATION

Financial ETU members are entitled to a wide range of industrial and support services including:

- Advice on your rights and entitlements at work
- Unfair dismissal representation
- Specialist industrial legal support and advice
- Workers compensation claims and assistance
- Conduct regular workplace safety inspections
- Support with accidents, injuries and fatalities
- Representation on & assistance with:
  - Electrical Licence Board
  - Long Service Leave Board
  - Counselling and/or disciplinary matters
  - Pay and industrial matters



### DISCOUNTED LEGAL ADVICE

ETU members are entitled access to a wide range of legal services provided by Eureka Lawyers, including advice relating to workers compensation, motor vehicle / transport accidents, criminal matters, wills and estates, medical negligence, conveyancing and much more at a discounted rate.

### INSURANCE COVERAGE

#### AMBULANCE COVER



The ETU offers emergency ambulance cover of up to \$1000 as a safety net for members and their dependent family (spouse/partner or any dependent children up to 18 years of age or up to 25 years of age if in full time study). If no

other insurance applies. Members must pay the ambulance invoice first and claim the reimbursement from the Union as we cannot make payments direct to the provider on your behalf.

#### JOURNEY COVER with **Protect**

The ETU provides Journey Cover to members if they are injured travelling to or from work. The cover provides for 100% of wages up to \$1200 per week for up to 104 weeks (2 years), to the age of 70. Please note, Journey Cover is not the same as Income Protection insurance. Please talk to your Organiser about Income Protection as it may be included in your EBA.

#### FUNERAL / DEATH PAYMENT

Families of deceased ETU members can claim a \$5000 payment towards funeral costs. Members must have been financial up to the date of their passing and is dispensed to your estate. We offer cover to the age of 70. Conditions apply for insurance coverage, refer to the office more information.
